1. The price of items should not exceed Maximum Retail Price (MRP) and inclusive of all taxes, incidental charges, insurance charges, freight etc.
2. Parties/Firms must mention their GST No. in their quotation.
3. Parties/Firms must mention the brand name, model no. power input (Watts) and other specification of the product in their quotations along with product brochure which they are going to supply. Party should also enclose the company provided specification of the items (company brochure) along with technical bid.
5. The party should provide warranty/free maintenance after installation of the machines. The supplier must provide details of warranty service provider like name, address, contact no., period of warranty, etc.
6. The quoted amount should be mentioned in both numbers and words. Any bid (in Annexure-A and Annexure-B) with illegible, incorrect, incomplete or inconsistent particulars, figures and words will be summarily rejected.
7. Quotations should be signed on all pages and stamped by the authorized person of the bidding firm.
8. No advance payment will be provided to the supplier or installer. Payment against Bill/Invoice shall be released only after successful supply/installation of the machines. All payments will be made through RTGS.
9. Delivery should be within 7 days of issue of purchase order. A penalty of Rs 500/- per day will be imposed on the bidder.
