Now, sealed tenders are invited from experienced network solution providers OEMs and Authorized Channel Partners for the upgradation/expansion of the Wi-Fi setup; supply of equipment; installation, maintenance, and monitoring of the Wi-Fi access points (internal and external) in various buildings of Ram Lal Anand College Campus'

The duly stamped tenders are to be submitted in prescribed format (to be signed by authorized signatory on every page). The envelope containing the tenders superscripted with "Tender for the Wi-Fi installation" should be addressed to Principal, Ram Lal Anand College and reach the college office before 3.00 p.m. on Friday, 17.03.2017. The bids received after the due date and time will not be entertained. The bids will be opened at 3.00 p.m. on 20.03.2017, in the presence of the bidders or their representatives if any.

This notice does not claim to contain all the technical information that bidders may require for submitting their tenders. Bidders may conduct their own inspection on the site with the permission of the undersigned for the accurate data/details regarding items to be supplied, places of installations etc. The college may in its absolute discretion, update, amend or supplement the information contained in this document whenever required. Further, the college reserves the right to accept or reject any of the bids without assigning any reason.

Other conditions:

1. The successful bidder should execute a performance agreement on a Stamp Paper worth Rs. 100/- at the time of acceptance of the contract that they will abide by the terms and condition of the contract.
2. A portion of the payment (i.e. 10% of the total bill amount excluding the installation and labor charges) will be released by the college only after three months of successful installation of this project.
3. The rate quoted should be the net amount inclusive of all the taxes/ freight charges etc., if any.
4. Each bid document should contain the following items given below
